No 03/15/2007-1lg3(4lg3)/1085616/1 Whereas the Governor of Punjab, in exercise of the powers conferred under Section 61(2) of the Punjab Municipal Act, 1911(Act 3 of 1911) is pleased to grant sanction for levy of municipal tax @ 2% on consumption, use or sale of electricity within the municipal limits in the State of Punjab.

Therefore, the State Government, by exercising its powers under Section 62(A)(1) of the Punjab Municipal Act, 1911(Act 3 of 1911) directs all the Municipal Councils and Nagar Panchayats in the State of Punjab to levy municipal tax @ 2% on consumption, use or sale of electricity within the municipal limits with effect from the 1st day of November, 2017.


