No 03/15/2007-1lg3(4lg3)/ 111156 | 1) Whereas the Governor of Punjab, in exercise of the powers conferred under Section 90(4) of the Punjab Municipal Corporation Act, 1976 is pleased to grant sanction for levy of municipal tax @ 2% on consumption, use or sale of electricity within the municipal limits in the State of Punjab.

Therefore, the State Government, by exercising its powers under Section 90(4) of the Punjab Municipal Corporation Act, 1976 directs all the Municipal Corporations in the State of Punjab to levy municipal tax @ 2% on consumption, use or sale of electricity within the municipal limits with immediate effect.
