(no. as per respective notifications attached) under section 07 of "the Punjab Prohibition of Cow Slaughter Act 1955 (15 of 1956)". In relation to this, publications were published by publishing public information through two newspapers and suggestions and objections were invited from the public but, because of no objections and suggestions were received the respective ULBs have imposed the cow cess.

2 Therefore, Governor of Punjab, in the exercise of powers conferred under section 07 of the Punjab Prohibition of Cow Slaughter Act 1955 is pleased to announce the sanction for levy of following type of fee (cow cess) on the following types of items in the area of respective ULBs and whose collective agencies are declared in the tables below:
