

It is informed that an amount of Rs.4,19,74,004/- (Four Crore Nineteen Lac Seventy Four Thousand Four only) has been released on 26.03.2018 as Grant-in-aid under the Punjab Municipal Fund Scheme (Non-Plan Scheme) by the State Government, which has also been credited in the Centralized Water Supply & Sewerage O & M A/c No.001301054247 of the Directorate office. It is informed that the above Grant-in-aid is the share of 60 ULBs on account of 2/11 share of O & M charges of Water Supply & Sewerage as per detail attached herewith in **Annexure-A**, deducted from their installment of Punjab Municipal Fund.


