In exercise of the powers conferred by Section 95 of the Punjab Municipal Corporation Act, 1976 and 157 of the Punjab Municipal Corporation Act, 1976 and all other powers enabling him in this behalf, the Governor of Punjab is pleased to revise domestic water supply bills and sewer user charges as under:-

| Plot Size          | Water charges        | Sewer Charges   | Remarks  |

| Upto 125 sq. yard  | Nil                  | Nil   | No changes, same as previous   |
| Above 125 sq. yard | Rs.50/- per<br>month | Same as per<br>prevailing rates<br>for all categories.<br>No change | Water supply charges have been reduced to Rs 50/-per month for all categories of plot above 125 sq. yards. |

It has also been decided that henceforth electricity bills for water supply schemes of urban areas will be paid by Government to PSPCL directly.

In addition, arrears of water supply and sewerage user charges for domestic connections (including principal amount, interest and penalty) accumulated as on date 21.10.2021 are also hereby waived off.
