No. G.S.R. 24/P.A. 3/1911/Ss. 38, 39 and 240/Amd:/2007.—The following draft of rules further to amend the Punjab Municipal Employees, Pension and General Provident Fund Rules, 1994, which the Governor of Punjab proposes to make, in exercise of powers conferred by sub-section (1) of section 240 read with sections 38 and 39 of the Punjab Municipal Act, 1911 (Punjab Act No. 3 of 1911), and all other powers enabling him in this behalf, is published as required by sub-section (5) of section 240 of the said Act, for the information of the persons likely to be effected thereby.

Notice is hereby given that the draft will be taken into consideration by the Government on or after the expiry of a period of thirty days from date of publication of this notification in the Official Gazette, together with any objection or suggestion, which may be received by the Secretary to Government of Punjab, Department of Local Government, Chandigarh, from any person before the expiry of period so specified with respect to the said draft, namely:—

#### DRAFT RULES

- 1. These rules may be called the Punjab Municipal Employees, Pension and General Provident Funo Rules, 2007.
- 2. In 5the Punjab Municipal Employees, Pension and General Provident Fund Rules, 1994 (herein after referred to as the said rules), in rule 4, for sub-rule (2), the following sub-rule shall be substituted, namely :—
  - "(2) The fund for the employees, who are members of the provincialised and non-provincialised services, shall be established by the Regional Deputy Director."
- 3. In the said rules, in rule 6, for sub-rule (1), the following sub-rule shall be substituted, namely :—
  - "(1) The fund for the employees, who are members of the provincialised and non-provincialised services, shall be kept and administered by the Regional Deputy Director."
