No. 8/22/06-ILG-IV/3409 :-In exercise of the powers conferred under Section 71 of the Punjab Municipal Act, 1911 (Act No. 3 of 1911) read alongwith Section 19 of the Punjab General Clauses Act, 1898 and all other powers enabling him in this behalf, in partial modification of Notification No. 2/2/2003-3LGIV/6514, dated 2nd May, 2003, the Governor of Punjab is pleased to exempt with effect from 26.6.2006 all residential units having plot area upto 5 Marla (125 sq. yards), situated within the limits of Municipalities, in the State of Punjab, from payment of water supply and sewerage charges. Arrears of Water Supply and Sewerage Charges of these units are also waived off.
