The Department of Local Government, Punjab vide Public Notice No. DLG-RC-2021/01, dated 04.01.2021; had issued the schedule w.e.f. 11.01.2021 to 23.01.2021 for scrutiny of certificates/other documents of the candidates who had applied for 332 posts (except 22 posts of clerk) for physically handicapped persons.
